#### 4.1. Description of first aid measures

##### General information

In all cases of doubt, or when symptoms persist, seek medical advice. In case of unconsciousness give nothing by mouth, place in recovery position and seek medical advice.

##### Following inhalation

Remove casualty to fresh air and keep warm and at rest. In case of irregular breathing or respiratory arrest provide artificial respiration.

##### Following skin contact

containers with pressure - no pressure vessel! Always keep in containers that correspond to the material of the original container. Follow the legal protection and safety regulations.

**Precautions against fire and explosion:**

Vapours are heavier than air. Vapours form explosive mixtures with air.

7.2. **Conditions for safe storage, including any incompatibilities**

**Requirements for storage rooms and vessels**

Storage in accordance with the Ordinance on Industrial Safety and Health (BetrSiVO). Keep container tightly closed. Do not empty containers with pressure - no pressure vessel! Smoking is forbidden. Access only for authorised persons. Store carefully closed containers upright to prevent any leaks.
